#### DRAFT City of Silver Lake Regular Session Minutes Monday, June 19, 2023

The Governing Body of the City of Silver Lake met in regular session at City Hall on Monday evening June 19, 2023, at 5:30 PM with Mayor Mack Smith conducting the meeting and the following Councilmembers present: Steve Pegram, Heath Robinson, and Larry Ross (3). Absent: Brad Bryant, and Jake Fisher (2). Also present was City Attorney Todd Luckman, Public Works Utility Superintendent Cary Deiter, Public Works Assistant Brad Kirk, Police Chief Marc McCune, City Clerk Liz Steckel, and Assistant Clerk Marie Beam.

Local resident, Jerry Barker of 501 Lakeland Drive, was present for public comment to request an extension to Lakeland Drive. Mr. Barker was informed that it is not in the current budget to add this to the 2023 Street Project, and City Attorney Luckman added that with proper approval he may extend the road himself.

Local resident, Jonah Bishop of 309 Gemini, was present for public comment to ask Councilmember Pegram for clarification on statements that were previously made regarding local business support for a 1% local sales tax. Councilmember Pegram stated that there are local businesses in support of the local sales tax, and that the recent community survey results reflect 79% of respondents were in favor of a local sales tax. Mr. Bishop wanted to know what the people in the county believe. He intends to run these numbers.

A motion was made by Councilmember Ross to approve the minutes of the June 5, 2023 meeting as written. The motion was seconded by Councilmember Pegram and carried.

Claim vouchers in the amount of 15734.64 dollars were submitted to the Council for appropriation. An Ordinance entitled "An Ordinance Appropriating Money to Pay Certain Claims" was introduced. A motion was made by Councilmember Ross and seconded by Councilmember Robinson that said Ordinance be accepted as read and was then placed on final passage by a roll call vote: AYE: Steve Pegram, Heath Robinson, and Larry Ross.(3) NAY: None. With no further discussion the Ordinance was declared passed and was given No. 2569.

Councilmember Pegram made a motion to approve a Salary Ordinance for the City Clerk, the Assistant Clerk and the Part-Time Police Administrative Assistant. The motion was seconded by Councilmember Ross and was then placed on final passage by a roll call of the following vote: AYE: Steve Pegram, Heath Robinson, and Larry Ross (3). NAY: None. With no further discussion, the Ordinance was declared passed and was given No. 2570.

Local residents Cori Wegner and Julie McDaniel were present to request a donation for the Second Annual Silver Lake Relay for Life, which will take place on Saturday, August 26, 2023, from 6 PM until midnight. A motion was made by Councilmember Pegram to donate 500 dollars towards the 2023 Relay for Life. The motion was seconded by Councilmember Robinson and carried.

Mr. Ngole presented a letter signed by several local residents, requesting Council to amend the City Code to allow chickens within City limits. Council and City Attorney Luckman discussed the possibilities and process of making this change. Council directed City Attorney Luckman to present sample Chicken Ordinances at the next meeting.

As the next step in strategic planning for the City, Council discussed developing a plan to review, implement, and enforce City Codes on a yearly basis. City Attorney Luckman suggested starting off with the easily abated nuisances, such as grass, junk in yards, and untagged cars. Silver Lake City Code, section 8-903 requires that vehicles be both operable and display a visible tag.

Police Chief McCune reported that he is currently completing end-of-fiscal-year reporting for the Kansas Bureau of Investigation and the Attorney General's office.

Public Works Superintendent Deiter introduced the new Public Works Assistant, Brad Kirk. Deiter reported that they had cut the slag on Sage Road today in preparation of the 2023 Street Project.

Deiter informed Council that there is a leaking fire hydrant on Mercury that will need to be replaced in addition to the valve next to it. Evergy will need to move a brand-new light pole that has been installed directly beside the hydrant. RDR will jet the hydrant in order to determine the depth before we order a replacement. Deiter will report to Council when there is new information.

Superintendent Deiter reported that his staff started spraying for mosquitos Wednesday night at 9 PM. Mayor Mack Smith reported positive feedback about less mosquitos the following day. Deiter said they would likely spray two evenings this week, and that they would continue once or twice a week at least until the lake dries up.

City Attorney Luckman reported that the Board of Zoning has granted a special use permit to Silver Lake Schools-Special Services (Greg Harmon) for a coffee shop, to be located at 301 E. Railroad Street.

Attorney Luckman confirmed that we had submitted our special question on sales tax to the county election office.

Mayor Mack Smith noted that a resident had approached him with questions about having bees in City limits.

Mayor Smith was invited and attended the retirement reception for Kansas Highway Patrol Colonel Herman Jones.

AN ORDINANCE REGULATING THE OWNERSHIP AND KEEPING OF CHICKENS IN THE CITY OF SILVER LAKE, KANSAS AND REPEALING ALL ORDINANCES IN CONFLICT THEREWITH.

#### BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SILVER LAKE, KANSAS:

**SECTION 1.** There shall hereafter be an additional Article added to Chapter II of the Code of the City of Silver Lake. Such Article shall be Article 4 and shall be entitled: CHICKENS.

**SECTION 3.** Section 2-402 shall be added to the Code and shall read as follows: "GENDER OF CHICKENS. Only female chickens shall be allowed within the city, with no limitation on species. Roosters shall not be permitted."

SECTION 4. Section 2-403 shall be added to the Code and shall read as follows: "HENHOUSE. Henhouses shall be provided for all chickens kept within the city and shall be designed to provide safe and healthy living conditions for the chickens while minimizing the adverse impacts to other residents. The henhouse shall be a minimum of square feet in size per chicken, up to chickens. All henhouses shall be well maintained. All henhouse structures shall be enclosed on all sides and have a roof and doors. All henhouse access doors must be able to be shut and locked at night. Windows and vents must be covered with predator-proof and bird-proof wire containing less than one (1) inch openings."

SECTION 5. Section 2-404 shall be added to the Code and shall read as follows: "CHICKEN PENS. Enclosed chicken pens shall be provided for all chickens kept within the city. The pen shall be a minimum of \_\_\_\_\_\_\_ square feet in size per chicken. Such pens must be made of sturdy wire fencing, aviary netting or solid roofing. If wire fencing is used, it must be \_\_\_\_\_\_\_ gauge. All chicken pens must be at least \_\_\_\_\_\_ feet tall in height."

SECTION 6. Section 2-405 shall be added to the Code and shall read as follows: "LOCATION OF HENHOUSES AND CHICKEN PENS AND CONSENT OF NEIGHBORING PROPERTIES. No henhouse or chicken pen shall be located closer than \_\_\_\_\_\_\_ feet to any property line or any adjacent property and may not be within any setbacks required by City ordinance or zoning regulation. All henhouses and chicken pens must be located at least \_\_\_\_\_\_ feet from the nearest neighbor's residence. All henhouses and chicken pens shall be located in the backyard of the residence at issue. "Backyard," as used in this Section, shall mean that area of a lot that is located between the back of a house and the rear property line. The permit application shall require that any person wishing to keep chickens within the City of Silver Lake must have signatures of all property owners within \_\_\_\_\_\_\_ feet of the applicant's property line. This shall be measured from the closest property line to the neighbor, and not from the location of the henhouse or

chicken pen. Signatures of all neighboring property owners must be gathered on an annual basis, as a part of the permitting process, and it will not be assumed by the City that any neighboring property owner is agreeable to the allowance of chickens without an updated, yearly signature and date on every annual permit."

- **SECTION 7.** Section 2-406 shall be added to the Code and shall read as follows: "SANITARY CONDITIONS. All henhouses and chicken pens shall be kept clean, dry, odor-free and in a sanitary condition at all times. All henhouses and chicken pens shall also be constructed and repaired to prevent rats, mice or other rodents from being underneath or within such structures. All feed and other items associated with the keeping of chickens that are likely to attract or to become infested with or infected by rats, mice or other rodents shall be protected so as to prevent rats, mice or other rodents from gaining access to or coming into contact with them. All henhouses and chicken pens may be inspected at any time throughout the permit year by the Public Officer."
- **SECTION 8.** Section 2-407 shall be added to the Code and shall read as follows: "MANURE. Provision must be made for the storage and removal of chicken manure. All stored manure shall be covered by a fully-enclosed structure with a roof or lid over the entire structure. All manure not properly stored and not used for composting or fertilizing on the premises shall be removed."
- SECTION 9. Section 2-408 shall be added to the Code and shall read as follows: "LOCATION OF CHICKENS; SLAUGHTERING. Chickens must be kept within a henhouse or a chicken pen at all times. No chickens may be slaughtered within the limits of the city."
- **SECTION 10.** Section 2-409 shall be added to the Code and shall read as follows: "RUNNING AT LARGE PROHIBITED. It shall be unlawful for any person to allow or permit a chicken or chickens of any kind to run or be at large at any time in the City. For the purposes of this Section, the term "at large" shall be defined to include those times during which any chicken shall not be confined or kept in pens sufficiently strong or constructed to keep such chicken on the premises of their owner or keeper."
- SECTION 11. REVOCATION AND DENIAL OF PERMIT. A permit to keep chickens within the City may be denied or revoked by the City Council where there is a risk to public health or safety or for any violation or failure to comply with any provisions of this Article.
- **SECTION 12.** NOTICE: Any person, corporation, partnership, association or other entity found by the City Council to be in violation of any provision of this Ordinance or any such person, corporation, partnership, association or other entity who has been denied a permit or had a permit revoked, shall be served a notice of such violation, denial or revocation. The notice shall be served on the owner or agent of the owner of the property at issue by restricted mail or by personal service, or if the property is unoccupied and the owner is a nonresident of the city, then by mailing the notice by restricted mail to the last known address of the owner.
- **SECTION 13.** SAME; CONTENTS. The notice shall state the condition(s) which is/are in violation of the provisions of this Ordinance. The notice shall also inform the person, corporation, partnership association or other entity that:
  - (a) He, she or it shall have 10 days from the date of serving the notice to abate the condition(s) in violation of the provisions of this Ordinance; or
    - (b) He, she or it has 10 days from the date of serving the notice to request a hearing before the governing body as provided by Section 16 of this Ordinance;
    - (c) Failure to abate the condition(s) or to request a hearing within the time allowed may result in prosecution as provided in this Ordinance and/or abatement of the condition(s) by the city as provided by this Ordinance.

SECTION 14. FAILURE TO COMPLY; PENALTY. Should the person, corporation, partnership association or other entity fail to comply with the notice to abate the conditions that are in violation of this Article or request a hearing, the City may file a complaint in the Municipal Court against such person, corporation, partnership, association or other entity and upon conviction of any violation of provisions of this Article, such person, corporation, partnership, association or other entity, as appropriate, may be fined in an amount not to exceed \$100.00 or be imprisoned not to exceed 30 days or be both fined and imprisoned. Each day during or on which a violation occurs or continues after notice has been served shall constitute an additional or separate offense. If a permit is revoked for failure to comply with the terms of this Article, the property owner will not be allowed to apply for another permit for chickens for at least one (1) calendar year from the revocation of their permit. If a property owner has its permit revoked a second time for failure to comply with the terms of this Article and fails to cure that noncompliance, the permit will be revoked for at least a three (3) year period from the date of the second revocation.

**SECTION 15. ABATEMENT.** In addition to, or as an alternative to prosecution as provided in herein, the City Council may seek to remedy violations of this Ordinance in the following manner: If a person to whom a notice has been sent pursuant to section this Ordinance has neither alleviated the conditions causing the alleged violation nor requested a hearing before the governing body within the time periods specified herein, the City Attorney may present a resolution to the governing body for adoption, authorizing the City Council or other agents of the city to abate the conditions causing the violation at the end of 10 days after passage of the resolution. The resolution shall further provide that the costs incurred by the city shall be charged against the lot or parcel of ground on which the violating conditions were located as provided in this Ordinance. A copy of the resolution shall be served upon the person in violation in one of the following ways:

- (a) Personal service upon the person in violation;
- (b) Service by restricted mail; postage prepaid, return receipt requested; or
- (c) In the event the whereabouts of such person are unknown and the same cannot be ascertained in the exercise of reasonable diligence, an affidavit to that effect shall be made by the City Council and filed with the city clerk, and the serving of the resolution shall be made by publishing the same once each week for two consecutive weeks in the official city newspaper and by posting a copy of the resolution on the premises where such conditions exist.

**SECTION 16. HEARING.** If a hearing is requested within the 10-day period as provided in Section 13, such request shall be made in writing to the governing body. Failure to make a timely request for a hearing shall constitute a waiver of the person's right to contest the findings of the City Council before the governing body. The hearing shall be held by the governing body as soon as possible after filing of the request therefore, and the person shall be advised by the city of the time and place of the hearing at least five days in advance thereof. At any such hearing, the person may be represented by counsel, and the person and the city may introduce such witnesses and evidence as is deemed necessary and proper by the governing body. The hearing need not be conducted according to any formal rules of evidence. Upon conclusion of the hearing, the governing body shall record its determination of the matter by means of adopting a resolution and serving the resolution upon the person in the manner provided in Section 15.

**SECTION 17. COSTS ASSESSED.** If the city abates any conditions in violation of this Article, the cost of abatement, including attorney's fees, shall be charged against the lot or parcel of ground on which the violating conditions were located. The city clerk shall, at the time of certifying other taxes to the county clerk, certify the costs as provided in this Ordinance. The county clerk shall extend the same on the tax roll and it shall be collected by the county treasurer and paid to the city as other city taxes are collected and paid.

SECTION 18. REPEAL OF CONFLICTING ORDINANCES. Dear Silver Lake City Council,

My name is Cheryl Workman. I live down the street from the family who is asking to have chickens in city limits; my address is 304 Mercury. There are many reasons for which I am not in favor of an ordinance that would allow chickens in town. I fear that having chickens in the city limits causes a health hazard due to the increased risk of parasites and the many insects, including flies that love chickens. Having chickens in town could also draw wild animals into town that bring danger and disease; many chicken owners complain about raccoons, foxes, coyotes and snakes that come to kill or eat their chickens. Chickens fly, and will certainly find a way to get out of a fence and attract running neighborhood dogs from all over. These are just a few of the reasons why I am opposed to an ordinance allowing chickens in the city limits in Silver Lake. I did not move into town to have a farm next door.

I appreciate your consideration of my feelings on the matter. I've spoken to some citizens who live in the city-limits and below are their signatures in opposition of the chicken ordinance.
