1	3-2-1981	Exempting the city from K.S.A. 59-5001 to 59-5017, and any amendments thereto.
2	1-7-1983	Exempting the city from K.S.A. 15-201, and any amendments thereto. Repealed by Charter Ord. 9.
3	4-5-1993	Exempting the city from K.S.A. 15-204, and any amendments thereto; providing for the creation of the office of City Treasurer; providing for the manner of appointment thereto and removal therefrom; providing for the duties of City Treasurer and amendment of code §§ 1-301, 1-302, 1-303, 1-304, 1-305, 1-306, 1-308 and 15-103; Sections 2 and 4 repealed by Charter Ord. 6.
4	8-1-1994	Exempting the city from K.S.A. 79-5020 through 79-5033, inclusive, and providing substitute and additional provisions on the same subject removing any limitation of aggregate tax levies.

7	11-18-1996	Exempting the city from K.S.A. 12-4112, and providing substitute and additional provisions therefore authorizing the assessments for court costs in cases heard in the Municipal Court of the city.
8	7-19-2004	Exempting the city from K.S.A. 41-712, and providing substitute provisions on the same subject in accordance with the provisions of Article 12, Section 5 of the Constitution of the state.
9	12-7-2016	Exempting the city from the provisions of K.S.A. 15-201, relating to the election of officers, their terms of office, transitions to November elections, the filling of governing body vacancies, and nomination petitions; and, providing substitute and additional provisions on the same subject; and repealing Charter Ord. 2.

1235	12-5-1983	Granting an electric franchise to the Kansas Power and Light Company, a state corporation, its successors and assigns, to build transmission lines and occupy said lines for 20 years, and to occupy and use the streets, avenues, alleys, bridges, parks, parking and public areas of the city for the placing and maintaining of equipment in order to carry on the business of selling and distributing electricity in the city.
1236	12-5-1983	Granting a gas franchise to the Kansas Power and Light Company, a state corporation, its successors and assigns, to build transmission lines and occupy said lines for 20 years, and to occupy and use the streets, avenues, alleys, bridges, parks, parking and public areas of the city for the placing and maintaining of pipelines and other equipment in order to carry on the business of selling and distributing natural gas in the city.
1652	9-18-1995	Granting a nonexclusive franchise to Galaxy Telecom, L.P., a Delaware limited partnership, its successors and assigns, to build, construct, operate and maintain a broadband communications

1665	2-21-1996	Granting United Telephone Company of Iowa d/b/a United Telephone Company of Eastern Kansas, a franchise to use the streets, avenues, boulevards, alleys and other public places in the city, to continue to conduct the business of constructing, installing maintaining, managing and operating a telephone system with all necessary poles, wires, cables, fixtures, conduit and apparatus.
1843	2-7-2001	Amending Ord. 1652 and providing the effective date of transfer.
1887	9-18-2002	Renewing the cable television franchise with Galaxy Cable, Inc., d/b/a Galaxy Cablevision, and amending that ordinance to provide for increased franchise fees and establishing a local access cable channel.
1922	9-15-2003	Granting to Westar Energy, Inc., its successors and assigns, an electric franchise, prescribing the terms hereof, and relating thereto, and repealing all ordinances or parts of ordinances inconsistent with or in conflict with the terms hereof.
1925	10-20-2003	Amending Ord. 1665 relating to a franchise agreement with Sprint pursuant to K.S.A. 12-2001.

1932	1-5-2004	Granting to Kansas Gas Service, a Division of Oneok, Inc., its successors and assigns, a natural gas franchise, prescribing the terms thereof and relating thereto, and repealing all ordinances or parts of ordinances inconsistent with or in conflict with the terms hereof.
2000	2-8-2006	Renewing the cable television franchise with Galaxy Cable Inc., d/b/a Galaxy Cablevision, and approving the change of expiration date.
2181	9-7-2011	Granting Kaw Valley Electric Cooperative, Inc., a Kansas corporation, its successors and assigns, an electric franchise, prescribing the terms thereof and relating thereto, and repealing all ordinances or parts of ordinances inconsistent with or in conflict with the terms hereof.
